Introduction

Purpose

The purpose of this document is to provide State, Local, Territorial, and Tribal governments with an overview of resources and programs capable of being used to respond to and recover from the impacts of natural disasters, human-made disasters, public health emergencies, economic hardships, humanitarian crisis, security issues, expanding incidents, and complex emergencies.

This document is subject to change as new programs are approved, deadlines shift, and organizational guidance documents are released and will continue to be updated and distributed as needed. It is intended for use as a tool for future planning and to promote partnership between resource providers and state, local, territorial, and tribal entities. For the most up to date and accurate programmatic information, interested parties should visit each individual organization's website or work directly with the relevant entity.

R1. FY22 Supplemental Nutrition Assistance Program (SNAP): Process, & Technology Improvement (10.580)

Resource Type: Grant

Agency/Organization: Department of Health and Human Services

Funding Type: Non-Supplemental

Program Description : Section 11(t) of the Food and Nutrition Act of 2008 (Public Law 116-94), as amended, Grants for Simplified Application and Eligibility Determination Systems and Improved Access to Benefits, authorizes the Food and Nutrition Service Agency (FNS) to annually award up to \$5 million¹ in grants to State agencies administering the Supplemental Nutrition Assistance Program; State or local governments; agencies providing health or welfare services; public health or educational entities; or private nonprofit entities, such as community-based or faith-based organizations, food banks, or other emergency feeding organizations. These grants, known as Process and Technology Improvement Grants, allow applicants to "develop and implement supplemental nutrition assistance program simplified application and eligibility determination systems."

Process and Technology Improvement Grants support efforts by State agencies and their community-based and faith-based partners to develop and implement projects that focus on improving the quality and efficiency of Supplemental Nutrition Assistance Program (SNAP) operations and processes.

R2. FY22 Local Food for Schools (LFS)

Resource Type: Cooperative Agreement

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description : The U.S. Department of Agriculture (USDA), Agricultural Marketing Service (AMS), requests applications from state governments for the Local Food for Schools (LFS) Program. The goal will be to establish cooperative agreements with state governments for the purpose of purchasing domestic, locally grown foods from local producers, small businesses, and socially disadvantaged farmers/producers for distribution to schools. AMS will make only one award per state government; agencies within the state must coordinate if more than one agency wishes to implement this program. The state governments can also partner with local organizations. Up to \$200 million is available from funds authorized under section 5(c) of the Commodity Credit Corporation Charter Act (15 USC 714c(c)). This announcement identifies the eligibility criteria for LFS applicants, the application forms, and associated instructions needed to apply for an LFS award. AMS encourages applications that benefit both small businesses and socially disadvantaged farmers/producers and provides food distribution to schools. For cooperative agreements intending to serve these entities, applicants should engage and involve those beneficiaries when developing projects and applications. AMS would like these relationships and purchase and distribution channels to continue past the conclusion of this program.

The Local Food for Schools Cooperative Agreement Program (LFS) is authorized by section 5(c) of the Commodity Credit Corporation Charter Act (15 USC 714c(c)).

The purpose of this program is to increase purchasing of local and regional foods for distribution to schools.

The program achieves this purpose in the overarching goals below:

1. Provide an opportunity for states to strengthen their local and regional food system.
2. Help to support local, small, and socially disadvantaged farmers/producers through building and expanding economic opportunities.
3. Establish and broaden partnerships with farmers/producers and schools to ensure distribution of fresh and nutritious foods.

R3. FY22 Agriculture & Food Research Initiative (AFRI): Sustainable Agricultural Systems (SAS) (10.310)

Resource Type: Grant

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description : The Agriculture and Food Research Initiative's Sustainable Agricultural Systems (SAS) program area promotes the sustainable supply of abundant, affordable, safe, nutritious, and accessible food and other agricultural products, while enhancing economic opportunities and improving the long-term health and well-being of all Americans.

SAS seeks to help transform the U.S. food and agricultural system to increase production in sustainable ways as we approach a world population of 10 billion by 2050,

and doing so in the context of diminishing land and water resources, changing climate and increasing frequency of extreme weather events, threats of outbreaks of diseases and pests, and challenges to human health and well-being. Solving these challenges will require a convergence of science and technology to: optimize agricultural productivity; ensure safe, affordable, and nutritious supply of food; invigorate and realize the promise of the bioeconomy; and promote the development of a talented agricultural workforce.

Funding will support projects focused on increasing agricultural productivity; optimizing water and nitrogen use efficiency; protecting yield losses from stresses, diseases, and pests; reducing food-borne diseases; and advancing development of biobased fuels, chemicals, and coproducts. This RFA is soliciting creative and visionary project applications that use transdisciplinary teams and integrated research, education, and extension/outreach activities to promote convergence of science and technology to solve present and future food and agricultural production system challenges.

Successful projects will consider what has contributed to present successes of U.S. food and agriculture systems, and challenges to continued and future success. Agricultural systems are inclusive of values chains from production to consumption for food or other products from farms, ranches, and managed forests across the rural-urban continuum from conventional open-fields to controlled production in built environments.

Consideration must be given for how new strategies or other technical interventions may alter many factors involved in the conduct of the system. Applicants must demonstrate changes that are crucial to safeguarding the food and agricultural supply while ensuring the viability of the entire value chain. This includes profitability, natural resources quality, food safety and quality, and the health and well-being of people and communities. Additionally, the systems must help develop and execute approaches to reducing the ecological footprint, including, but not limited to, water and nutrient use, greenhouse gases, and energy use.

R5. Commodity Supplemental Food Program (CSFP) (10.565)

Program Description : The Commodity Supplemental Food Program (CSFP) works to improve the health of low-income persons at least 60 years of age by supplementing their diets with nutritious USDA Foods. USDA distributes both food and administrative funds to participating states and Indian Tribal Organizations to operate CSFP.

R7. Water & Waste Disposal Grants to Alleviate Health Risks on Tribal Lands & Colonias (10.770)

Resource Type: Grant

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description : This program provides low-income communities, that face significant health risks, access to safe, reliable drinking water and waste disposal facilities and services.

Funds may be used for:

- Construction of basic drinking water and waste disposal systems, including storm drainage

Colonias – This is a term used to describe subdivisions located outside incorporated areas along the U.S.-Mexico border where residents face significant health risks due to a significant portion of the community lacking access to clean, reliable, affordable drinking water and/or waste disposal systems.

Federally recognized tribes - federally recognized tribes are eligible for many USDA Rural Development programs. A list of all federally recognized tribes is published in the Federal Register and posted at <https://www.bia.gov/tribal-leaders-directory>. Additionally, a few RD programs include tribes on state reservations as eligible applicants. More information on those programs is available at the Government Accountability Office site.

R8. FY21 Water & Waste Disposal Loan & Grant Program (10.770)

Resource Type: Grant and Loan

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description : This program provides funding for clean and reliable drinking water systems, sanitary sewage disposal, sanitary solid waste disposal, and storm water drainage to households and businesses in eligible rural areas.

Funds may be used to finance the acquisition, construction or improvement of: drinking water sourcing, treatment, storage and distribution; sewer collection, transmission, treatment and disposal; solid waste collection, disposal and closure; storm water collection, transmission and disposal.

In some cases, funding may also be available for related activities such as: legal and engineering fees; land acquisition, water and land rights, permits and equipment; start-up operations and maintenance; interest incurred during construction; purchase of facilities to improve service or prevent loss of service; other costs determined to be necessary for completion of the project.

R9. Emergency Community Water Assistance Grants Program (10.763)

Resource Type: Grant

Agency/Organization: Department of Agriculture

Funding Type: Non-Supplemental

Program Description : This program helps eligible communities prepare, or recover from, an emergency that threatens the availability of safe, reliable drinking water.

- Water transmission line grants up to \$150,000 to construct waterline extensions, repair breaks or leaks in existing water distribution lines, and address related maintenance necessary to replenish the water supply
- Water source grants up to \$1,000,000 are to construct a water source, intake or treatment facility

This program helps eligible communities prepare, or recover from, an emergency that threatens the availability of safe, reliable drinking water. The following events qualify as an emergency:

- Drought or flood
- Earthquake
- Tornado or hurricane
- Disease outbreak
- Chemical spill, leak, or seepage
- Other disasters

NOTE: A federal disaster declaration is not required.

R11. Emergency Haying & Grazing

Program Description : To help livestock producers in approved counties when the growth and yield of hay and pasture have been substantially reduced because of a widespread natural disaster.

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) administers the Conservation Reserve Program (CRP), a federally funded voluntary program that contracts with agricultural producers so that environmentally sensitive agricultural land is

not farmed or ranched, but instead used for conservation benefits. Participants establish long-term, resource-conserving plant species, such as approved grasses or trees (known as “covers”), to control soil erosion, improve water quality and develop wildlife habitat. In return, FSA provides participants with rental payments and cost-share assistance. Contract duration is between 10 and 15 years.

Haying and grazing of CRP acres is authorized under certain conditions to improve the quality and performance of the CRP cover or to provide emergency relief to livestock producers due to certain natural disasters. There are two types of haying and grazing authorization: non-emergency and emergency.

R13. Community Facilities Direct Loan & Grant Program (10.766)

An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial or business undertakings.

- Community-based non-profit corporations; AND
- Federally-recognized Tribes.

Funds can be used to purchase, construct, and/or improve essential community facilities. All facilities financed in whole or in part with RHS funds shall be for public use.

Community facilities include (but are not limited to) those providing or supporting overall community development - such as hospitals, fire protection, public safety, libraries, education facilities, child care facilities, food recovery and distribution centers, assisted living facilities, group homes, mental health clinics, and shelters. Projects comprise community, social, health care, education, cultural, transportation, industrial park sites, fire and rescue services, access ways, and utility extensions. Examples of essential community facilities include:

- Health care facilities such as hospitals, medical clinics, dental clinics, nursing homes or assisted living facilities;
- Public facilities such as town halls, courthouses, airport hangars or street improvements;
- Community support services such as child care centers, community centers, fairgrounds or transitional housing;
- Public safety services such as fire departments, police stations, prisons, police vehicles, fire trucks, public works vehicles or equipment;
- Educational services such as museums, libraries or private schools;
- Utility services such as telemedicine or distance learning equipment; AND
- Local food systems such as community gardens, food pantries, community kitchens, food banks, food hubs or greenhouses.

Through TEFAP, the U.S. Department of Agriculture (USDA) purchases a variety of nutritious, high quality USDA Foods, and makes those foods available to State Distributing Agencies. The amount of food each state receives out of the total amount of food provided is based on the number of unemployed persons and the number of people with incomes below the poverty level in the state. States provide the food to local agencies that they have selected, usually food banks, which in turn distribute the food to local organizations, such as soup kitchens and food pantries that directly serve the public. States also provide the food to other types of local organizations, such as community action agencies, which distribute the foods directly to low-income households. Under TEFAP, states also receive administrative funds to support the storage and distribution of USDA Foods. These funds must, in part, be passed down to local agencies. TEFAP is administered at the federal level by the Food and Nutrition Service, an agency of the USDA.

- Testing, diagnosis or other services at a fixed or mobile location.

Up to 20 percent may be expended for planning and management development and administration. May be used to cover or reimburse allowable costs to prevent, prepare for, and respond to coronavirus incurred by a recipient, including for costs incurred prior

to the date of enactment of this Act. Waives the limitation on for public services activities to prevent, prepare for, and respond to coronavirus.

R20. Families First Coronavirus Response Act: FY20-21 Aging & Disability Nutrition Services Programs

- \$10 million Nutrition Services for Native Americans.

Emergency loan funds may be used to restore or replace essential property, pay all or part of production costs associated with the disaster year, pay essential family living expenses, reorganize the farming operation, and refinance certain debts.

EZ Guarantee loans are guaranteed farm ownership and operating loans with a shortened application process and reduced paperwork designed to meet the needs of smaller, non-traditional, and niche-type operations.

Conservation loans help you complete a conservation practice in an approved conservation plan.

Land contract guarantees provide certain financial guarantees to the seller of a farm or ranch through a land contract sale to a beginning or socially disadvantaged farmer or rancher. The seller may request either of the following:

- **Prompt Payment Guarantee:** A guarantee up to the amount of three amortized annual installments plus the cost of any related real estate taxes and insurance. The seller must choose a third-party escrow agent who will handle transactions related to the contract.
- **Standard Guarantee:** A guarantee of 90 percent of the outstanding principal balance under the land contract. The seller must choose a third-party servicing agent.

Highly Fractionated Indian Land Loans provide a way for tribes, tribal members, and tribal entities to purchase fractionated interests through intermediary lenders.
