





- Where is it taking Place?
- Who is Impacted?
- Who will benefit from the project?
- Can the money you are requesting make a difference?

"Please describe the economic impacts of the project."

Mission and Values



- Why your organization is best able to solve the problem
- Experience (past grants) & staffing
- Alignment with region/local strategic plans or CEDS
- A description of the impacted community
- What have you already committed?
- How the grant request/project Aligns with the Investment Priorities of the Grantee

EDA's Investment Priorities EDA investments should effectively address the creation and/or retention of high-quality jobs and document that the applicant can or will leverage other resources.

A competitive application must align with at least one of the following priorities:



Equity

- Recovery & Resilience
- Workforce Development
- Manufacturing
- Technology-Based Economic Development
- Environmentally-Sustainable Development
- Exports & FDI

The Ask

What's the Goal?

Jobs, quality of jobs, economic output. (EDA)

i.e. The overall purpose of the project is to provide economic stimulus for the Friendsville community that will stimulate potential commercial growth and industrial land development for future recruitment of industries into the northwest region of Blount County

Technical assistance to communities, states, and tribes to assess, safely clean up and sustainably reuse contaminated or blighted properties (EPA Brownfield)

RAISE Discretionary Grant Program helps communities build transportation projects that have significant local or regional impact and improve safety and equity. (USDOT)

Show Proof



 Socio-Demographic Data that helps define the problem and reveals your solution

- A budget and timeline
